Wyandot County Pig Scramble

- Age Divisions : 5-6, 7-8, 9-10, 11-12, 18+ (adult class)
- Age divisions 5-12 will have one boy and one girl class for each age division with a maximum of 15 participants per class. Adult class will be one unisex class with a maximum of 20 participants.
- Pig sizes will increase with age divisions
- Three pigs will be released in the arena per class for age divisions 5-12. Two pigs will be released for the adult class.
- **Public auction will be held after the scramble for the remaining pigs. All pigs must be transported off fairground property within 1 hour after event**

Pig Scramble Rules and Requirements:

1. Check in with staff Tuesday Sep 15, 2026 in Horse Arena at 6:00PM.
2. Ages 5-8 are required to have a parent/guardian present at check-in.
3. If participant is creating trouble for staff/volunteers or fellow participants, they will be dismissed without refund.
4. Participants must indicate their prize if they win, pig or money, on this form and cannot change form after form due date/time.
5. Prize pigs and auctioned pigs must be transported off fairground property with 1 hour after event.
6. Provide an acceptable form of transportation for your pig.
7. **All participants are required to wear and provide their own goggles during the event. NO SAFETY GLASSES!**
8. T-shirts will be provided for participants. Participants must wear short sleeve shirts.
9. If a participant has hold of a pig, no other participants will be allowed to touch the pig unless if breaks free. Referee calls are final!

I hereby acknowledge that participating in the Wyandot County Pig Scramble can be a potentially hazardous activity and that all participants should be in good medical and physical condition.
